Mail to UNITY HOUSE before the deadline date. After review by the Unity House Child Care Committee, parents will be notified by mail of their acceptance or denial.



# **Enrollment Periods**

Enrollment period: January 1 – February 15
ALL Applications Due: February 15

Coverage period: October – March
Enrollment period: July 1 - August 15
ALL Applications Due: August 15

**RENEWALS:** It is the applicant's responsibility to re-apply every 6 months. Applications <u>are not</u> automatically renewed.

# Requirements

THE FOLLOWING ITEMS MUST BE SUBMITTED BY August 15, 2004 BY THE APPLICANT!

- An official Unity House APPLICATION
- Payment for the <u>Application Processing Fee</u>\*
  - **New apps:** \$20.00 per child If application and pertinent forms are downloaded & printed from the **Unity House website**, the fee will be discounted to \$15.00 per child.
  - Renewal apps: \$12.50 per child
- A copy of the **Child's Birth Certificate** (NEW applicants only)
- A **photo** of your child
- Waiver and Immunity of Action form required to be completed by HERE, Local 5 members only.

\*Make check payable to: UNITY HOUSE and write child's name at the bottom of the check. This fee is non-refundable under any circumstance.

### NEW REQUIREMENT DUE: Dec. 30, 2004

 Volunteer Service: Parents or any family member is now required to participate in UNITY HOUSE's "Education in Action" program by completing 10 hours of volunteer service before full assistance is awarded. See application attachment for more details.

Based on the information provided on your application, UNITY HOUSE will contact the PRESCHOOL directly and request that they submit the following items:

- Release and Waiver Form
   Indemnifies and holds blameless Unity
   House from any potential liability.
- Preschool Verification Form

To confirm that the Center (preschool) is licensed and/or certified as required by the State of Hawaii.

- Child Enrollment Verification Form
   To certify that the child is enrolled during the period of the award.
- License A copy of the Group Child Care Center's (Preschool) current Operating License.

# What type of Child Care Assistance is covered by this program?

- The child must be enrolled in a "Group Child Care Center"<sup>1</sup>, as defined by the State of Hawaii.
  - According to the State of Hawaii's Revised Statutes, 1992 Supplement, Volume 6 Titles 20-21, Chapters 346-398:

<sup>2</sup>Eligibility of each preschool is reviewed and approved by Unity House twice a year. Therefore, the current status of each preschool may change period to period.



# Who is eligible to apply?

All beneficiaries who are dues paying members (i.e. parents, grandparents, or legal guardians) for the last six months or more, and in good standings with one of the following organizations:

(Proof of beneficiary status will be verified by the respective office)

- Unity House, Inc.
- Hotel Employees and Restaurant Employees, Local 5\*\*
- Hawaii Teamsters and Allied Workers Union, Local 996
- Child must be enrolled & attending the Group Child Care Center (preschool) before the start of the program period. Limit one award per child.
- Child's parents/guardians must be employed.
- Special family circumstances concerning beneficiary status for eligibility purposes will be taken into consideration by the Child Care Program Committee or as the Board of Directors may determine.

\*\*For H.E.R.E., Local 5 members only: A Waiver & Immunity of Action form must be signed by the union representative before any award assistance is distributed.



# Award Amount

- Total award per 6-month period is \$294, which is paid directly to the Group Child Care Center (preschool).
- Awards are good for as long as the child is enrolled during the six (6) month period.
